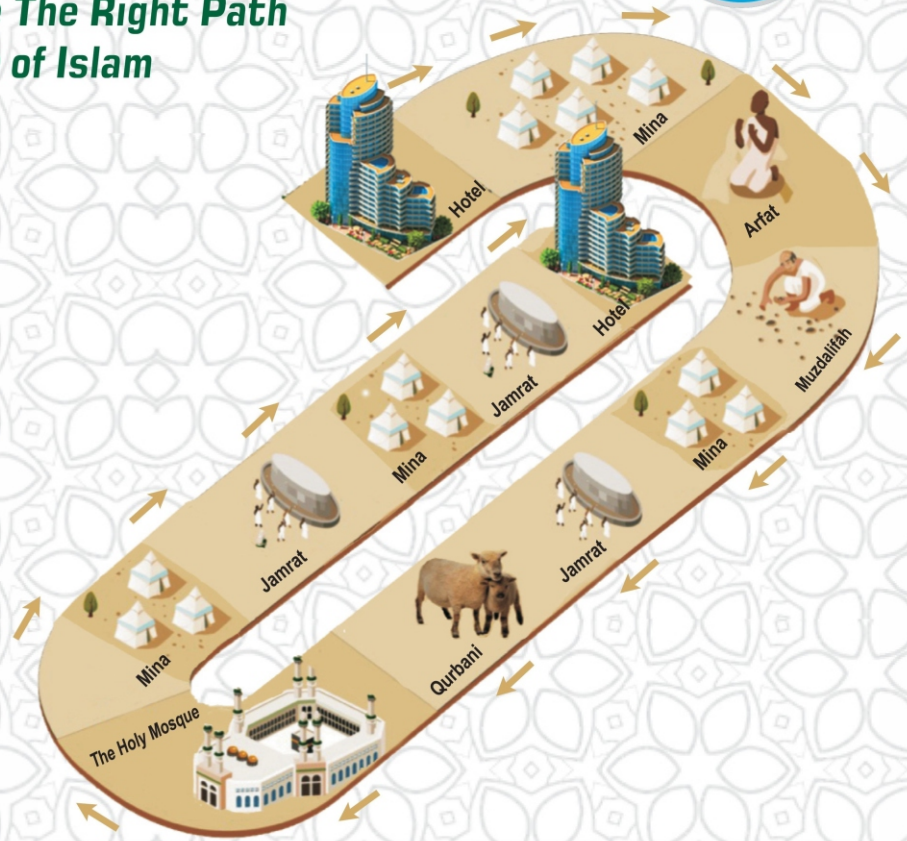

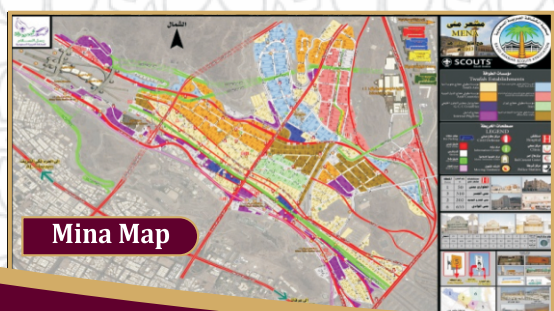

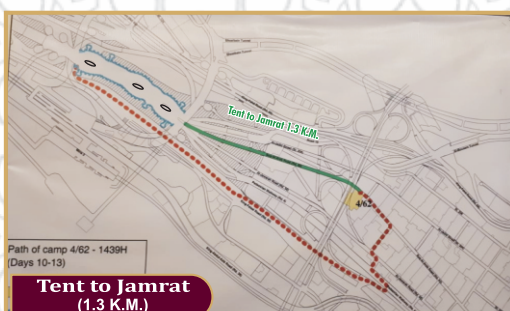

INTENDING PILGRIMS SHOULD BE FULLY VACCINATED WITH AN APPROVED COVID-19 VACCINE, ATLEAST ONE MONTH BEFORE ACTUAL DEPARTURE FOR HAJ 2022 ONLY SUCH PILGRIM SHALL BE ALLOWED TO TRAVEL FOR HAJ-2023 1444H.

◆ **PREFACE:**

Haj is obligation on all muslims having physical and financial ability to perform the rituals. Haj pilgrimage is physically taxing as it involves arduous journey from one place to another on foot and by various other modes of transport. Haj is performed in a foreign land i.e in the Kingdom of Saudi Arabia (KSA). As per General Saudi Guidelines on edibility to perform Haj or Umrah, a Haj Pilgrim should be fit on various level financial, physical, behavioral and mental.

The arrangements for Haj 2023 – 1444H will be made under special circumstance with Special Norms, Rules & Regulations, Eligibility Criteria, Age Restrictions, Health and Fitness requirements and other relevant conditions as Kingdom of Saudi Arabia may determine and deem appropriate amid Corona virus pandemic. Hence, the entire process of inviting applications from Indian Pilgrims for Haj 2023 is Provisional and is further subject to the final Guidelines of KSA.

It may also be noted that KSA may even cancel the Haj 2023/1444H entirely or partially for international pilgrims depending upon the prevailing conditions of COVID-19 Corona Virus Pandemic at the time of Haj. HGOs will therefore, not be liable for any modification, correction or even cancelation of entire Haj process by KSA. Further, HGOs does not bear any liability / responsibility or financial obligation for any such modification, correction, change or cancellation announced by KSA in due course.

Under the prevailing conditions, KSA may allow Haj aspirants having sold health without co-morbidities like Heart ailment, Diabetics, Respiratory disorders, Pregnancies and other serious illness for Haj 2023 during Corona Virus Pandemic. The possibilities of further restrictions for Haj 2023/1444 H due to strict health protocols and social distancing norms to be issued by KSA can't be ruled out/. Consequently the expenditure on Haj 2023 is also expected to be relatively higher than during normal period. Therefore, pilgrims who are financially should enough to bear the expected extra expenses should only apply, if they fulfill all other eligibility norms for Haj 2023.

Haj Pilgrims in turn represent their own country of origin as such it become obligatory upon them to maintain a composure and decent behavior in all stages of the pious Haj journey.

◆ **HAJ APPLICATION PROCESS:**

KSA has not yet announced any Guidelines for Haj 2023 / 1444H therefore these guidelines are provisional only. It is expected that may changes may be made by KSA for Haj 2023 in the Norms/Guidelines for performing Haj 2023 like Eligibility, Health, Age, Social distancing norms etc. the restriction for Haj 2023 due to health protocols and age limit for Haj pilgrim decided by the KSA will be finally applicable and Hajis will be selected accordingly. At present it is expected that the Ministry of Haj & Umrah, KSA may even impose restriction and allow pilgrims of age limits up to 65Yrs for Haj 2023. Therefore as of now the intending pilgrims falling under the said permissible age limit are only eligible to apply for Haj 2023 / 1444H.

Those having severe medical conditions such as Terminal cancers, Heart Ailment, Co-morbidities, Advanced Cardiac, Respiratory, Liver or Kidney Diseases, Infectious Tuberculosis Disease, or Senility are strictly not allowed at this stage due to the prevailing Covid-19 situation.

The Ministry of Health, KSA will finalize and issue necessary guidelines on the health protocols for Haj 2023 including the age restrictions for the Haj Pilgrims visiting the Kingdom from outside. The Health related norms towards International Travel have become stringent due to the COVID-19 pandemic. The detailed health guidelines will be issued in due course of time and Haj 2023 will be strictly governed as per the guidelines/norms finalized by KSA.

◆ **Pregnant ladies and those above the prescribed age limit in view of Corona Virus Pandemic are strictly restricted for Haj 2023 as of now.**

◆ **PROTOCOLS AS ANTICIPATED BY CGI/JEDDAH ARE AS FOLLOWS:**

VAT on goods and services has been increased to 15% (from 5% earlier) by Saudi Government.

- i. New Haj Visa Fees of SAR 300/- per Pilgrim which was not being charged earlier.
- ii. New Fee of SAR 100/- for Mandatory Health Insurance likely in Haj 2023.
- iii. Rent for accommodation in Makkah and Madinah likely to rise due to VAT increase and a possible increase in space / pilgrim requirement and other additional requirement.
- iv. Transportation cost of likely to increase due to VAT increase and possible requirement of additional norms due to COVID-19.
- v. Significant rise in the cost of services in Mashaer expected (Say from SAR 1.050/- in Haj 2022 to SAR 2.500/- in HAJ 2023) due to possible introduction of mandatory services and new norm in view of COVID-19. However this is tentative estimate. The actual cost on Haj 2023 will be finalized only after KSA decides the actual guidelines/norms for Haj 2023.

The pilgrims must have received the full dose of approval Covid-19 vaccine in the KSA, all pilgrims are required to present a certificate proving the same which are attested from the official Health Authorities in their countries.

The Pilgrim must present a RT-PCR examination certificate with a negative result that they are free of emerging corona virus issued by a reliable laboratory from country of the pilgrims. This should not exceed 72hrs from the sample collecting time until departure to the Kingdom of Saudi Arabia. Pilgrim without certification of negative test will not be permitted to board the plane.

CONDITIONS APPLY

- ◆ All the Payment to be made in favor of Mubarak Haj & Umrah Service by cheque/Draft/Pay order only.
- ◆ The tour cost based on air ticket, Foreign Exchange & Moallim draft as calculated on last Hajj-1443 / 2022.
- ◆ All mentioned services will commence after reaching our accommodation in Makkah.
- ◆ At the Jeddah airport at least 8 to 10 hours time will be taken to complete the formalities.
- ◆ From Jeddah airport to Makkah building via Moallim office it takes another 3 to 4 hours.
- ◆ Flight schedule and itinerary are subject to changed without prior notice.
- ◆ The tour cost has to be cleared before Submission of Passport for HAJ VISA. 25th May 2023 Otherwise Your Booking will be Cancelled And your Seat will be given to Waiting List Haji.
- ◆ We are not responsible for any luggage lost / misplaced or any incident, excess luggage charges are to be paid by HAJJI. , Hajji is responsible for ZAM ZAM & luggage until He/She return to HYDERABAD.
- ◆ Transportation from Madinah hotel to airport are arranged by govt of Saudi, buses will be arranged as per their convenience.
- ◆ As per the term and condition of Ministry of Haj Saudi Arabia, Maktab-UI Wakla (Naqaba) is the nodal agency for pilgrim Transportation in Saudi Arabia, Airport to airport, waiting time up 8 hours in several boarding points which is beyond the control of Mubarak haj tours.
- ◆ All rules and regulations of both the countries i.e. KSA and India are to be followed by the pilgrim.
- ◆ Pilgrims are required to provide to the HGO their Medical and health requirements report and vaccination from their respective doctors as per HCOI guidance.
- ◆ The pilgrims must have received the full dose of approval Covid-19 vaccine in the KSA, all pilgrims are required to present a certificate proving the same which are attested from the official Health Authorities in their countries.
- ◆ All intending pilgrims are compulsory required to attend the orientation/training camp that'll be organized by the HGO before the departure of the haj group.
- ◆ During the five days of HAJ all accommodations, transportation and food will be provided by the Moallim (Service provider) only. Any alterations beyond the HGO capacity will not addressed by the HGO.
